#### AMVAC SNOW MOLD ASSURANCE PROGRAM-TERMS AND CONDITIONS

User must follow prescribed guidelines herein regarding application rates and timing for the user's region and apply on a minimum of three acres of greens or 20 acres of fairways in order to qualify for the AMVAC Snow Mold Assurance Program. Program purchases must be made between September 8, 2018 and November 21, 2018 and product applications must be made between September 8, 2018 (high elevation areas) and December 15, 2018 ("Qualifying Period"). All claims must be reported to and submitted in writing to your AMVAC territory manager within two (2) weeks after snowmelt and no later than April 30, 2019. In the event you notify your AMVAC territory manager of snow mold breakthrough exceeding 15%, an AMVAC representative will investigate and, if warranted, supply AMVAC products for application replacement with a value not to exceed the value of the AMVAC products already purchased and applied by user on the applicable acreage during the Qualifying Period. A "Breakthrough" is defined as more than 15% occurrence of snow mold control as compared to untreated areas of similar turf density, turftype, and environment at the sole discretion of the AMVAC representative. AMVAC's determination as to whether less than acceptable control exists will be final. AMVAC retains the right to audit purchase records in assessing claims made pursuant to the Program. AMVAC will not pay for any application for rescue treatments. Cultural practices, mechanical issues or any other factors that are deemed contrary to standard practices and methods for preventive snow mold control will render the claim ineligible. AMVAC reserves the right to modify or discontinue this Program at any time without prior notice.
