

AMVAC NPMA PestWorld 2018 Giveaway Promotion Rules & Regulations

Official Rules of Play

1. **NO PURCHASE NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING. CONTEST VOID WHERE PROHIBITED.**
2. **ELIGIBILITY:** Contest entrants must be a legal resident of the fifty (50) United States or the District of Columbia, and eighteen (18) years of age or older as of January 1, 2018. Only licensed or certified pest management professionals or employees of pest control companies will be eligible to receive free Navigator SC termiticide/insecticide. Employees, officers and directors of AMVAC Chemical Co. ("Sponsor"), its parent, subsidiaries, divisions, affiliates, suppliers, printers, distributors and advertising, promotional and judging agencies, (and their respective IRS dependents, immediate family members [parents, children, siblings and spouse]) and individuals residing in their same household (whether or not related) are not eligible to participate in or win the AMVAC NPMA PestWorld 2018 Giveaway Contest ("Contest").
3. **TIMING:** Entry for the Contest will begin on October 23, 2018 at 02:00:01 p.m. Eastern Time ("ET") and end on October 25, 2018 at 1:29:59 p.m. ET (the "Contest Entry Period").

4. **TO PARTICIPATE IN THE CONTEST:**

How to Enter: The contest will be held in booth #629 during PestWorld 2018, in Orlando, Florida. Participants who scan their PestWorld badge and step into the "Navigator Bug Chamber" will be entered for the Grand Prize drawing. Contestants will then have :15 to collect as many of approximately 150, fan-driven pieces paper in the booth. If they collect specially marked pieces of paper, they will be eligible to win free Navigator SC termiticide/insecticide and/or a free t-shirt.

5. **GRAND PRIZE:** A Navigator of the Seas® cruise prize package for winner and one (1) guest which includes: round trip, coach-class air transportation within the continental United States for 2 from a major airport near winner's home (determined by Sponsor in its sole discretion); 1 night's hotel accommodations (single room, double occupancy) at port city; round trip ground transportation between hotel in port city and port; Navigator of the Seas cruise for winner and guest (see details below); terms and conditions apply. Travel must occur between 12/1/2018 and 8/1/2019. Christmas/New Year's and other sailing blackout dates may apply. Winner must provide Sponsor with desired travel dates a minimum of forty-five (45) days in advance of desired departure date. Sponsor will select cruise destination/itinerary after receiving date requests from winner. Approximate retail value: \$2,500. Winner must book flights at least 21 days prior to departure. Travel subject to availability and blackout dates. Travel must be round trip. Sponsor will determine airline and flight itinerary in its sole discretion. No refund or

compensation will be made in the event of the cancellation or delay of any flight. Travel is subject to the terms and conditions set forth in these Official Rules, and those set forth by the Sponsor's airline carrier of choice as detailed in the passenger ticket contract. All expenses, travel, and other costs not expressly stated in the package description above are the sole responsibility of winner. Travel companion must execute liability/publicity releases prior to issuance of prize documents. Winner and travel companion must sign cruise line passenger ticket contract prior to being allowed to board the cruise. Winner and guest must be able to provide proper passport documentation. 6. **GRAND PRIZE WINNER SELECTION:** On or about October 30, 2018, Administrator or an independent judging agency will select one (1) entry for the Grand Prize described in Section 5 in a random drawing of all valid entries received. Each separate entry will be included in the random Grand Prize drawing. There will be a total of one (1) Grand Prize. The entrant will be contacted using the email address and/or phone number provided with the entry and will be awarded the prize, subject to verification of eligibility and compliance with all the terms of these rules. Sponsor's decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion. Winners will be notified on or about November 6, 2018.
7. **NAVIGATOR SC GIVE AWAY:** Approximately thirty (30) cases of twenty (20) oz. Navigator SC termiticide/insecticide will be awarded during the Contest period. Total approximate retail value: \$5,000. Ten (10) of the hundred and fifty (150) pieces of paper in the "Navigator Bug Chamber" will be designated as "winning" the free product. Contestants must collect one (1) or more of those ten (10) sheets of paper during fifteen (15) seconds to be considered for the prize. Limit one (1) case per contestant. Only licensed or certified pest management professionals or employees of pest control companies will be eligible to collect the prize. Conditional winners will be provided a statement which must be completed and signed verifying eligibility before the prize is awarded. The Navigator SC will be delivered via a common carrier to the winners' business location on or around December 1, 2018.
8. **T-SHIRT AWAY:** Approximately one hundred to two hundred (100-200) t-shirts will be awarded during the contest period. Total approximate retail value: \$2,000. Fifteen (15) of the hundred and fifty (150) pieces of paper in the "Navigator Bug Chamber" will be designated as winning a t-shirt. Contestants must collect one (1) or more of those fifteen (15) sheets of paper during fifteen (15) seconds to win a t-shirt, which will be awarded in the booth. Limit one (1) t-shirt per contestant
